Product Description

Multi-purpose cleaner with superior cleaning power for walls and floors. Deodorises and sanitises leaving a pleasant lemon fragrance.

Product Features

- The product is a mild cleaner and will remove most greasy soils and scuff marks. Cleaned surfaces may be buffed to an attractive sheen without the need for rinsing prior to buffing.
- The product's lemon fresh smell makes it an ideal cleaner for washroom floors and shower areas.
- It is safe to use on virtually all hard surfaces and can be used either via damp mopping, spray cleaning or machine scrubbing.

Direction for Use

- **For mopping and sanitising**- dilute at 1:125 in warm water.
- **For paintwork and washrooms** - dilute at 1:50 in warm water.
- Mopping operation - use a well wrung mop. Damp mop floor and allow to dry. If required, buff to a shine using an electrical buffing machine with fine grade nylon pad.
- Spray maintenance - apply by spray and immediately buff floor surface with a buffing machine as per mopping operation.
- General surface cleaning - apply by a clean, well wrung cloth or sponge. Wash surface in a conventional manner and allow to dry.

Shelf Life

- Shelf life 24 months, if stored as recommended.
- Use within 6 months of opening.

Storage

- Store in cool conditions away from direct sources of heat.
- Avoid extremes of temperature.
- Do not allow to freeze.
- Ensure the cap is tightly fitted after use.
- Keep out of reach of children.
